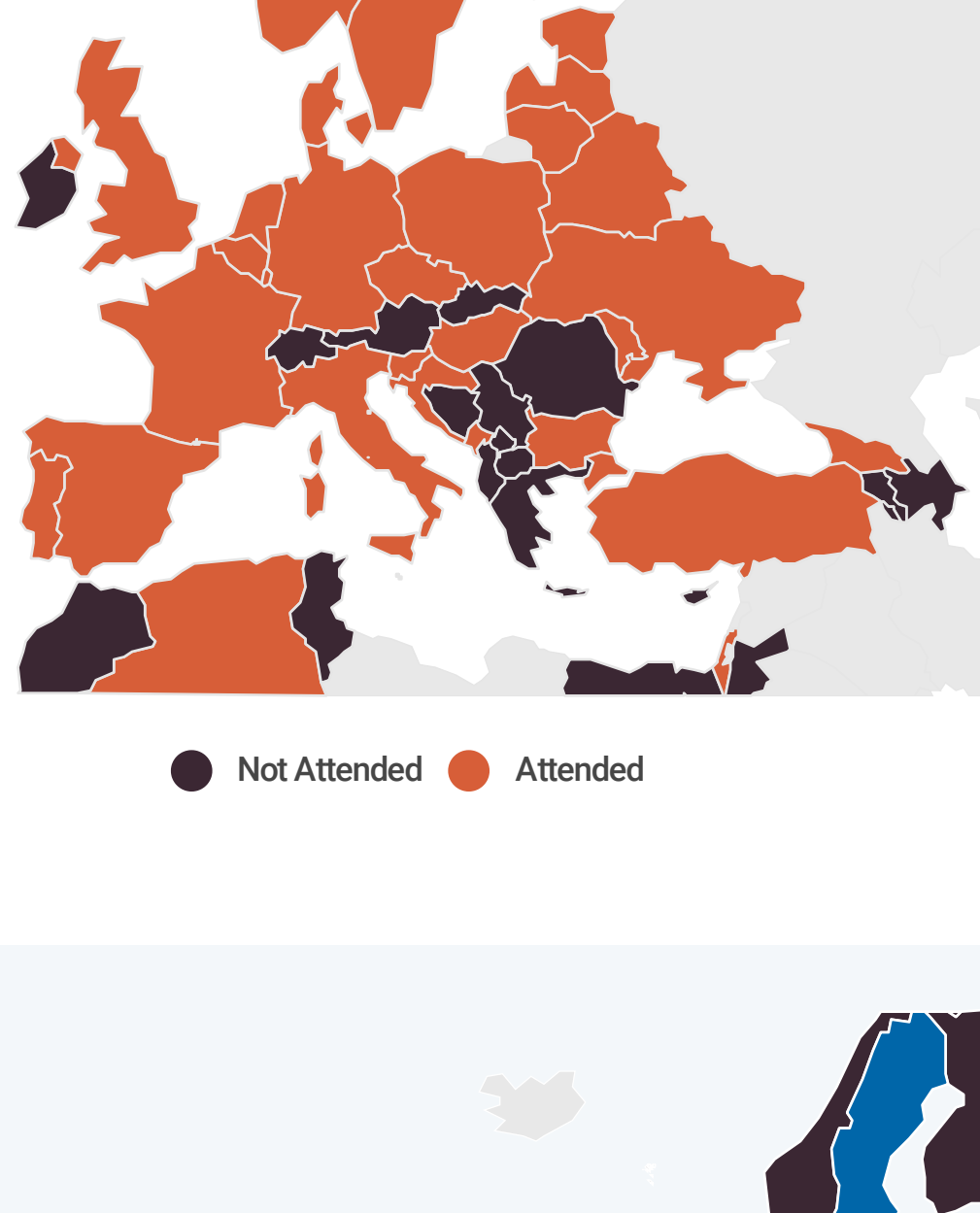

31 NABs attended this survey.

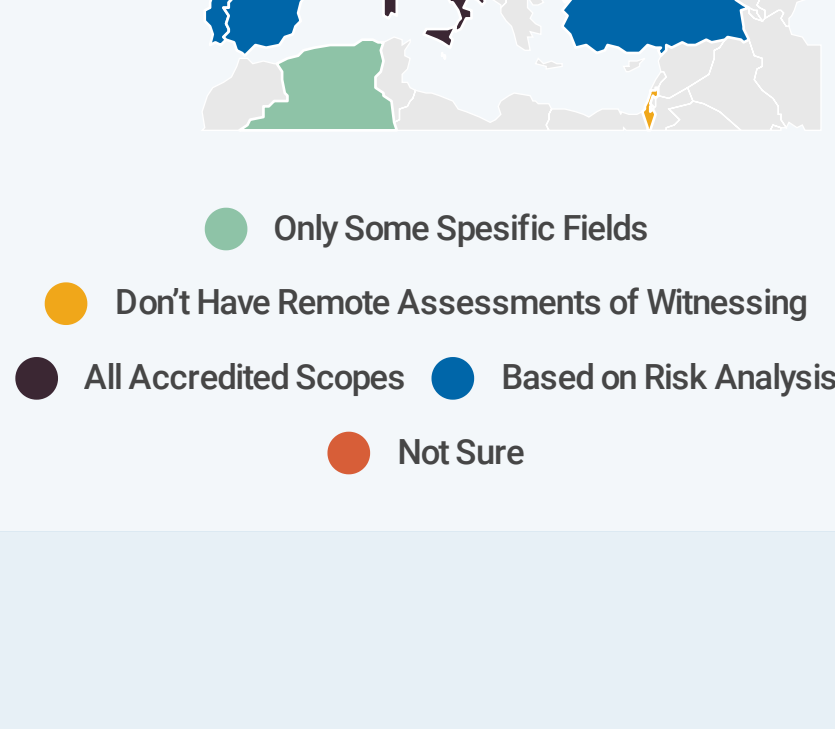

Which scopes can be subject to remote assessment in terms of inspection field?

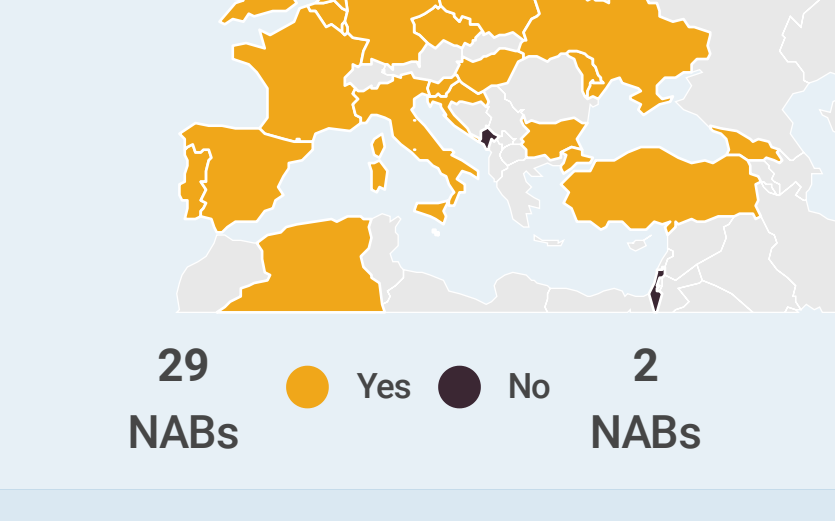
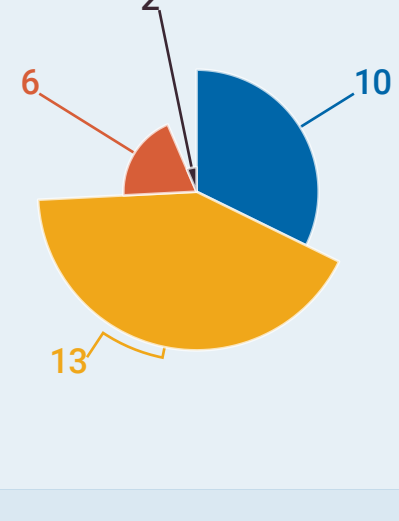

Has your AB conducted any remote assessment in the inspection field so far and for which scopes?

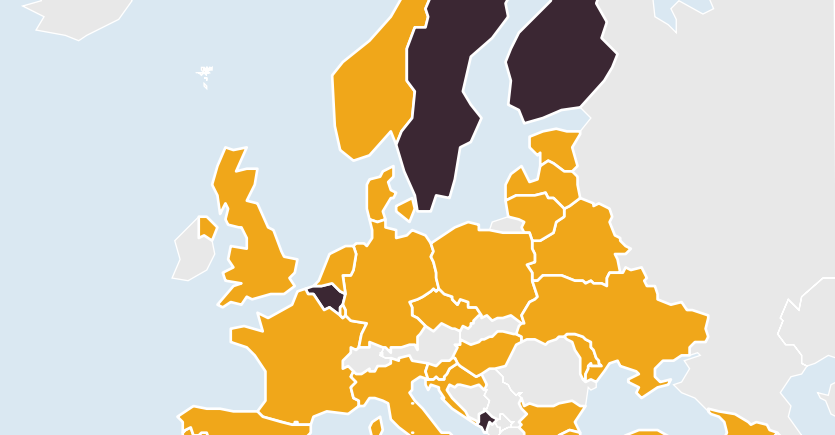

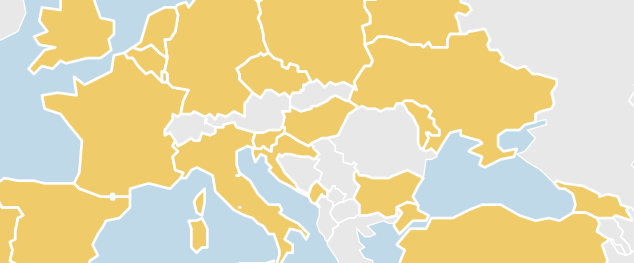
Have you encounter any examples where the CAB accredited by your NAB has performed remote inspection?

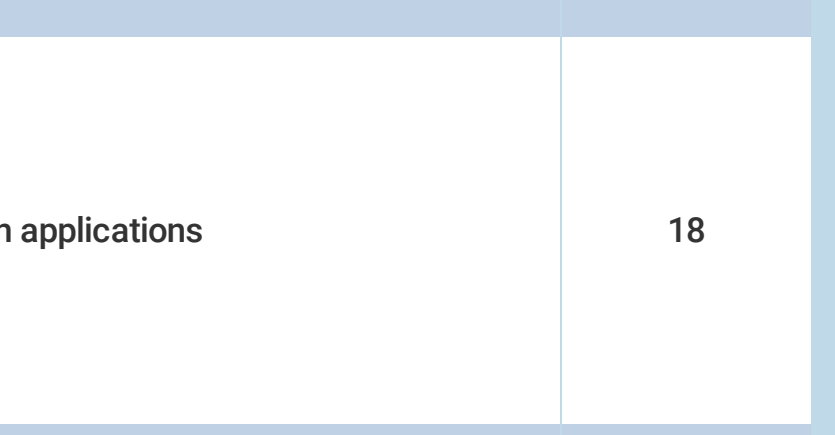
If you have any experience, how do you make sure that remote inspections are appropriate and fully documented as specified in item 7.1.3 of the ISO/IEC 17020 standard?

Conclusion

It turned out that most of the participating NABs are in favor of establishing a TFG on this issue.

We see that many NABs perform remote assessments and the problems are mostly common.

We also conclude that most of CABs do not perform remote inspections. Actually, they are not ready in this sense either. e.g. personnel qualification, technology.

It is not an issue that we can put forward a guidance document and decide on ourselves as an IC at Level 1 (Remote Assessment). But we can discuss at Level 2 and Level 3 (Remote Inspection). We should cooperate with other committees for Level 1.
