- CASCO continues to work on its strategic directions for the next 5 years & CASCO structure
 - Reappointment of Reinaldo Figueiredo as CASCO Chair for the 2022-2023 term
 - The 36th CASCO Plenary: 25 - 29 April 2022
 - The 2020 ISO management system standards (MSS) certification survey released
 - TIG works on a proposal to create a pool of experts to support CASCO Secretariat
 - STAR works on a deliverable on how to approach circular economy from a conformity assessment perspective
