4.1	a) Questions from member bodies organisations	No new question has been received. Some preliminary answers by the Review Group has been discussed and agreed at the meeting to update the EA-IC FAQ-list. One reason for this is maybe that ISO/IEC 17020 is an "old" standard and lots of questions has been answered.
	b) Questions from stakeholder organisations	No new question has been received. Some preliminary answers by the Review Group has been discussed and agreed at the meeting to update the EA-IC FAQ-list. The reason is maybe the same than above.
4.2	Database for EA-IC FAQs	Chair has informed that FAQs of HHC, CC, LC & IC have been discussed in last EA-EX meeting. It was stated that implementations were different from one to another committee. It has been decided that Committee Chairs should discuss and reach common solution on how to deal with FAQs. Actual just the EA-CC publishes the FAQs public available. EA-IC has denied this, but this will be discussed within the next EA-EX.

4.3	Application of ISO/IEC 17020 in the field of crime scene investigation (CSI)	AFORE is the “Accreditation of forensic laboratories in Europe” and an EU project. Project includes different work packages covering accreditation of scene of crime services, training of forensic personnel in accreditation matters and technical experts/assessors. An update of this project has been given.

5.1	EA IC Technical Networks Car inspection	The draft of the revised EA-5/02 as written by the TFG has been presented as well as the comments and a reference table comparing ISO/IEC 17020, ILAC P15 (2020) and the old EA-5/02 (2015). EA-IC has opened a 60-day comments period.
