#### 2- Discussion of the EU Blue Guide

The participants discussed the importance of the Blue Guide and agreed upon focusing specifically on Chapter 5 on Conformity Assessment, given that the subject is the most important for EUROLAB.

### 3- Decisions taken

It was agreed by all the participants to set a deadline of one week (until 14<sup>th</sup> October 2020) to read and leave comments on Chapter 5 and on the related points 4.3 on Technical documentation, 4.4 on EU declaration of conformity and 4.5 on Marking requirements.

These comments will follow in structure and format the same model provided by ISO for revisions of its documents. The comments will be sent to the EUROLAB secretariat and to the TCQA Chair I. Visiers. The comments will be further gathered and compiled before the next meeting of the WG.

A. Ribeiro proposed to the participants to read the EU Regulation 2019/1020 (on market surveillance and compliance of products), which replaced the EU Regulation 2018/1065, in order to have additional background information on previous revisions to the same subject.
